TO ENTER, SEND

1. Completed entry blank with a non-refundable entry fee of AUST \$15 per quilt. Make checks payable to Sue Dennis. If your quilt is selected there is a AUST \$40 fee to cover return shipping that you should enclose with the shipment of your quilt to your national coordinator.
2. A self addressed stamped envelope for each entry.
3. Two color slides or .jpg images submitted on CD-Rom or floppy disk (full view and close-up of the quilt). Identify each slide, CD or disk with your name, title of quilt and arrow indicating top of image (slides). All images are forwarded to the United States for jurying.

QUILT RETURN

Quilts will be returned via designated carrier only. Quilts will be insured for \$1,000 U.S. on return shipping. Quilts will be return shipped in early December 2009.

CONTEST CALENDAR

APRIL 24, 2009 - ENTRY FORM SUBMISSION

The entry form, a business-size self addressed stamped envelope, color slides or .jpg images and an AUST \$15 non-refundable entry fee for each item entered must be submitted and postmarked no later than April 24, 2009.

ENTRY FEE

There is a non-refundable fee of AUST \$15 per entry. If your quilt is selected there is a AUST \$40 fee to cover return shipping. Checks should be made payable to Sue Dennis.

JUNE 16, 2009 - NOTIFICATION & INSTRUCTIONS

Notification of the decision of Jurors and instructions for quilt shipment will be sent to selected entrants by June 16, 2009.

JULY 7, 2009 - DELIVERY OF QUILTS

All accepted entries must be shipped or delivered to the World Quilt & Textile National Competition Coordinator at the address listed below for judging and exhibition. Quilts must arrive by July 7, 2009.

CONTEST RULES

1. The World Quilt Competition is open to all, but entries must be the work of the person or group applying to the competition. Limit two entries per person or group. Family members and permanent employees of show management or sponsors are not eligible. Quilts must be constructed and quilted by the person(s) named on the entry form.

2. Only quilts and wall quilts are eligible. Entry must be quilted either by hand or machine (any brand sewing machine). No kits or tied quilts. **SIZE CHANGE:** Entries must be no smaller than 1,296 square inches and no larger than 11,600 square inches. To calculate square inches multiply the length of quilt in inches by the width of the quilt in inches.

3. Entries must have been completed in 2007, 2008, or 2009 and be in excellent condition. Quilts submitted to prior World Quilt Competitions (World Quilt & Textile Events) are not eligible.

4. Each entry must have a 4 inch sleeve casing as well as a cloth label with the name, address and telephone number of the entrant sewn securely to the back.

5. Ship the entry(ies) in a secure carton. Place the item(s) in a cloth sack and then a plastic bag. Please do not use Styrofoam or cellulose peanuts. Put name, address and phone number on each bag. The original carton will be used to return the item(s). Please remove all old labels from the carton prior to shipping.

6. All international entries must be available for display at the World Quilt Show-New England, the Pennsylvania National Quilt Extravaganza, the Pacific International Quilt Festival and the Greater Chicago Quilt Exposition from August 2009 through mid November 2009.

7. All quilts entered and accepted must be shipped through the National Competition Coordinator. All quilts shipped to the Festival through the National Competition Coordinator must be return shipped to the same National Competition Coordinator.

8. If accepted, images and photographs taken become the property of World Quilt Show/Mancuso Show Management for publicity and/or publication use.

9. Prize winners will be notified within fourteen (14) days of close of the World Quilt Show-New England. Viewer's Choice will be presented at the close of World Quilt Show-New England.

10. Filing of your signed entry form signifies agreement with these conditions.

11. "Best of Country" will only be awarded to quilters whose country has 10 or more quilts entered into this competition.

12. Quilts awarded Best of World, 1st, 2nd or 3rd Place Traditional or 1st, 2nd or 3rd Place Innovative will not be eligible for Best of Country Awards.
